1. Objectives and methodology





Objectives, methodology and sources of the Directory of subsidiaries of foreign companies in Catalonia

ACCIÓ's Directory of subsidiaries of foreign companies in Catalonia has a double objective:

- To comprehensively identify the subsidiaries of foreign companies present in Catalonia from all business sectors.
- To show foreign business activity in Catalonia in line with the criterion of presence in Catalonia and correcting its effect.

- It includes the subsidiaries of foreign companies in which foreign capital is the majority (50% or more).
- One company is counted for every tax identification number that exists in the Companies Register (not establishments).
- It includes companies from all sectors of the Catalan economy.
- These may be subsidiaries, branches and/or representative offices of foreign companies in Catalonia, as well as all types of establishment (production plants, R&D centres, sales offices, etc.), provided they are located in Catalonia.
- The information on shareholding percentages, corporate structures and basic

- data is that deposited by companies in the **Companies Register,** according to data consulted **in July 2023.**
- Subsidiaries of foreign companies with operations centres in Catalonia are considered, even if their head office or tax residence is outside Catalonia.
- In some cases, there is an ambiguity between the actual origin of the capital and the nationality of the company's headquarters (the country where the company is officially registered). Within Europe, this is the case with companies registered in Luxembourg, the Netherlands, Ireland and Switzerland, among others. We have tried to identify the ultimate origin of the capital, whenever possible.

The company data, the shareholding percentages, and the countries of origin of the capital are calculated based on different sources consulted:

- ORBIS (Companies Register), ACCIÓ CRM and information from foreign offices
- Economic and business press dossier (1st six months of 2023)
- Company websites





2. Executive summary





Main figures of the subsidiaries of foreign companies identified in Catalonia in 2023

In 2023, we have identified 9,255 subsidiaries of foreign companies in Catalonia, accounting for 1.44% of the total number of companies in Catalonia.

27.7% of the subsidiaries of foreign companies identified in Catalonia are large- or medium-sized.

50% of the subsidiaries of foreign companies in Catalonia are exporters, and account for 52.7% of exports from Catalonia.

The foreign subsidiaries in Catalonia account for 31.6% of turnover and 19.5% of employment in Catalonia.

25% of the foreign subsidiaries in Catalonia (2,355) were established in the past 5 years, and 57% are over 10 years old.

The automotive, food, chemicals and plastics, and pharmaceutical industries account for 50.1% of the turnover of subsidiaries of foreign companies with sites in Catalonia.

Of the 9,255 subsidiaries of foreign companies in Catalonia, 1,835 operate in technology sectors, accounting for 19.8% of the total.

The subsidiaries of foreign manufacturing companies represent 11.8% of the total and, by turnover, account for 24.4%.

In terms of country, particularly noteworthy is the significance of the United States, France, Germany, the United Kingdom, and Italy (58.8% of the total).

Europe is the area of origin of 3 out of 4 subsidiaries of foreign companies with a presence in Catalonia.






Evolution of subsidiaries of foreign companies in Catalonia

In 2023, the number of subsidiaries of foreign companies identified in Catalonia is 9,255.

This accounts for a 1.1% growth compared to the 9,155 identified in 2022, and a 62.14% growth compared to the 5,708 foreign subsidiaries identified in 2014.

Weight of the subsidiaries of foreign companies in Catalonia compared to the total number of companies, according to size

27.7% of the subsidiaries of foreign companies identified in Catalonia are large- or medium-sized, and 91.8% are SMEs.

43.6% of all large- and medium-sized companies in Catalonia as subsidiaries of foreign companies.






Distribution of the subsidiaries of foreign companies identified in Catalonia according to age (2023)

Age of the subsidiaries of foreign companies in Catalonia (2023)

The ecosystem of subsidiaries of foreign companies in Catalonia is dynamic and, at the same time, consolidated: 25% of subsidiaries of foreign companies in Catalonia have been created in the last 5 years, and 57% are more than 10 years old.




Main sectors of the subsidiaries of foreign companies with head office in Catalonia (number of companies)

The sector with most foreign subsidiaries with head office in Catalonia is that of infrastructure and construction, accounting for 13.6% of the total number of companies.

The ICT and electronics sector (with 917 foreign subsidiaries) and the machinery and equipment goods industries (with 622 foreign subsidiaries) account for 21.1% of the subsidiaries of foreign companies in Catalonia, positioning Catalonia as a driving force in Industry 4.0 also for foreign companies.






Main sectors of the subsidiaries of foreign companies with head office in Catalonia (turnover in millions of euros)

The automotive, food, chemicals and plastics, and pharmaceutical industries account for 50.1% of the turnover of subsidiaries of foreign companies with sites in Catalonia.







Subsidiaries of foreign companies in Catalonia by value chain

The subsidiaries of foreign trading companies account for 31.0% of the total, with a turnover of 32.8% of the total. The subsidiaries of foreign service companies account for 27.4% of the total, with a turnover of 10.8% of the total. The subsidiaries of foreign manufacturing companies represent 11.8% of the total and, by turnover, account for 24.4%.

5. Countries of origin and location in Catalonia of subsidiaries of foreign companies





Distribution by geographical area of origin of the subsidiaries of foreign companies in Catalonia (2023)

Europe is the area of origin of 3 out of 4 subsidiaries of foreign companies with a presence in Catalonia.

In terms of 2022, there was a noteworthy growth from Oceania and North America, and more moderate growth from Asia and South America.

Distribution by country of origin of the subsidiaries of foreign companies in Catalonia (2023)

The 9,255 subsidiaries of foreign companies present in Catalonia in 2023 are from 90 different countries.

89.5% of the foreign subsidiaries in Catalonia are from the top 20 countries. Particularly noteworthy is the weight of the subsidiaries of companies from the United States, France, Germany, the United Kingdom, and Italy, which as a whole account for 58.8% of the total.




Subsidiaries of foreign companies in technology fields in Catalonia

Of the 9,255 subsidiaries of foreign companies in Catalonia, 1,835 operate in technology sectors (*), accounting for 19.8% of the total and 5.9% more than the 1,733 foreign subsidiaries in 2022.

56.5% of the subsidiaries of foreign companies in Catalonia in technology sectors belong to the ICT and electronics sector.

(*) Foreign companies from the technology field are considered all companies from the following sectors, regardless of the value chain: ICT and electronics, electricity, audiovisual, video games, R&D, biotech, health and healthcare services, animal health, and mobility services.


Distribution of the subsidiaries of foreign companies in technology fields by sector (number of companies and % of the total number of technology companies)







Subsidiaries of foreign companies from technology sectors in Catalonia by country 2023



More than 55.7% of the subsidiaries of companies from technology sectors in Catalonia are from 4 countries (the United States, France, the United Kingdom, and Germany). The United States leads the ranking with 355 business subsidiaries. Japan appears 8th with 63 subsidiaries of companies, and China (including HK) stands 12th with 37 subsidiaries.
